



**SNAP LOCK® TRANSFERABLE LIFETIME WARRANTY
NON-PRORATED, LIMITED**

The seamless aluminum gutter installed using the Snap Lock Gutter System® by Truss ("Snap Lock System") sold and installed by Austin Gutterman, Inc. ("AGI"), is warranted to the original owner(s) named in this certificate against material and installation defects as listed below. This warranty remains in effect as long as the original property owner(s) is living and is the original owner(s) of the property to which the Snap Lock System was installed. In the event there is more than one original property owner, the warranty will remain in effect as long as one of the original property owner(s) is living and owns an interest in the property. This warranty is transferable by the original property owner(s) to subsequent owner. In the event of the transfer, the warranty period shall be five (5) years from the date of transfer. The property owner or subsequent owner bears the responsibility of proof of original installation, warranty and/or transfer.

When the property is owned by other than an individual, such as a school, corporation, church, government or business, the warranty period shall be twenty (20) years from the date of original installation and apply to material only.

WARRANTY COVERAGE:

AGI warrants that the Snap Lock System installed under the premium method of installation (including additional supports or wedges) will be free from material or installation defects for the period stated above. The aluminum products will not rust, burn, split or crack nor will the finish peel or flake under conditions of ordinary wear. AGI warrants that the wooden fascia material onto which the Snap Lock System is installed will be protected from wood rot and black mold caused by the Snap Lock System for the period stated above. Damage caused by water penetration from sources not related to the gutter and Snap Lock system is not covered. The gutter installed with the Snap Lock System will not pull away or sag for as long as you own the property to which the products were installed, subject to the terms and conditions listed below:

COVERAGE EXCLUSIONS AND LIMITATIONS:

This warranty does not include damage to fascia material on residences with Tile roofs or damage by animals, people or objects beyond the control of AGI. Improper draining due to house settling, wood shrinkage or any other distortion of the structure is not covered. Hail, hurricane, tornado, windstorm, lightning and other "acts of God" are not covered. Owner's failure to properly maintain the system, including regular, timely cleanouts (see Care and Maintenance of Aluminum Products) also voids warranty. The finish on the aluminum gutter is warranted by the manufacturer for 50 years from the original date of installation. Painting the gutter voids the manufacturer's finish warranty. Removing and re-installing the gutter voids warranty, unless performed by AGI. Owner shall be responsible for additional costs for removal and re-installation by AGI.

If the Snap Lock System installed by AGI fails to perform in accordance with these standards during the warranty period, AGI will upon notification, proof of warranty parameters and validation of the claim by inspection, either repair or replace, at its option, the defect without charge to the owner.

AGI's obligation under this warranty shall in no event exceed the original purchase price of the installed materials. If the products covered can not be repaired, replaced or refinished after a reasonable number of attempts, AGI will provide a refund, limited to the amount of the original contract.

REGISTRATION AND TRANSFER:

This warranty is valid only after the warranty agreement registration is completed by the AGI representative and signed by the original owner(s).

This warranty is transferable by the original property owner(s) to subsequent owner(s) provided AGI receives written notice of the transfer within thirty (30) days of new ownership. Owner and/or subsequent owner is responsible to complete the Transfer Information below and submit a copy of this document to AGI, along with a \$100 transfer fee, to at 12229 Roxie Drive, Austin, Texas 78729-7121. Failure to do so shall relieve AGI of any continuing obligation. If warranty is not transferred, credit for this warranty can be applied to the purchase of like rain control systems and warranty in the same city as long as warranty on the new system is equal to or greater in value.

CLAIM PROCEDURE:

Any claim must be presented to AGI within a reasonable period of time after discovering a defect. The claim shall include reference to the exact contract date and contract name and address. Contacts are to be made to AGI at 12229 Roxie Drive, Austin, Texas 78729-7121, (512) 450-1821.

AGREEMENT AND REGISTRATION:

To effect the registration of this warranty, this application is to be completed and signed by both AGI representative and the original property owner(s). Warranty becomes effective with payment of the dollar amount below and completed installation of the contracted rain control system with the Snap Lock System.
